

We get questions.....

- **Why aren't we having Early Voting?**

There is only one candidate running in the Special Republican Primary and only one candidate running in the Special Democratic Primary, therefore per State law, "there shall not be an early voting period".

- **Where do I vote on Election Day?**

You must vote at your assigned voting location. Check your voter registration card or the Polling Place Finder <https://maps.nashville.gov/PollingPlaceFinder/> or call the Election Commission at (615) 862-8800 for your correct voting location.

- **What do I need to bring?**

Voters must present a photo ID issued by the federal or Tennessee state government, unless exemption applies. *You do not have to present your Voter Registration Card to vote.*

- **Why do I have to choose a ballot?**

The election on June 15 is a primary election, so you will be asked, "**Which ballot do you prefer today?**".

You may indicate your preference and affiliation by pointing to the table sign at check-in:

- **Republican**
- **Democratic**

See T.C.A. § 2-7-115(b)

- **Is the paper ballot my receipt?**

NO!! You MUST insert your marked paper ballot into the secure scanner for your vote to be counted.

- **Does it matter how I insert my ballot into the scanner?**

It's your choice. Your vote will be counted whether you insert your marked paper ballot face up or face down.

We suggest inserting your paper ballot **face down for privacy**, but *it's up to you* .

Election Day Voting Locations

Voting locations in Tennessee House District 52 will be open 7am – 7pm on Election Day.

You must vote at your assigned voting location.

Check your voter registration card or the Polling Place Finder at maps.nashville.gov/PollingPlaceFinder for your correct voting location.
