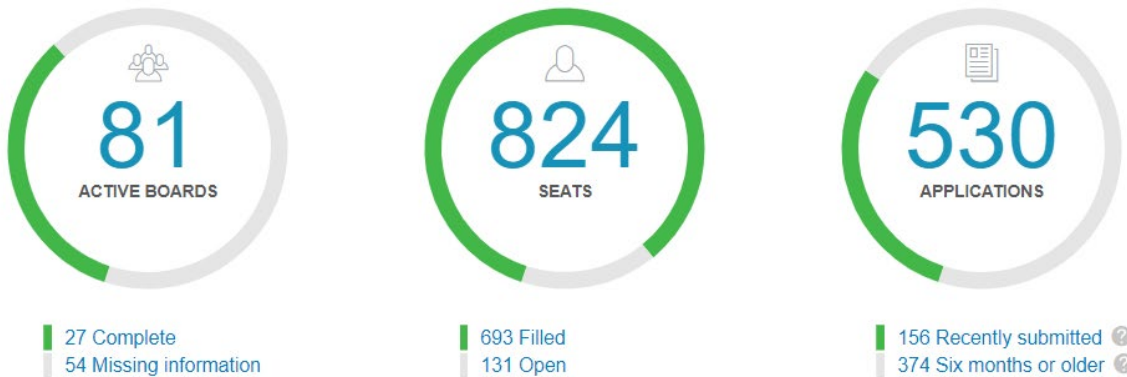


## Boards and Commissions Graphs (ADA Compliant Script)

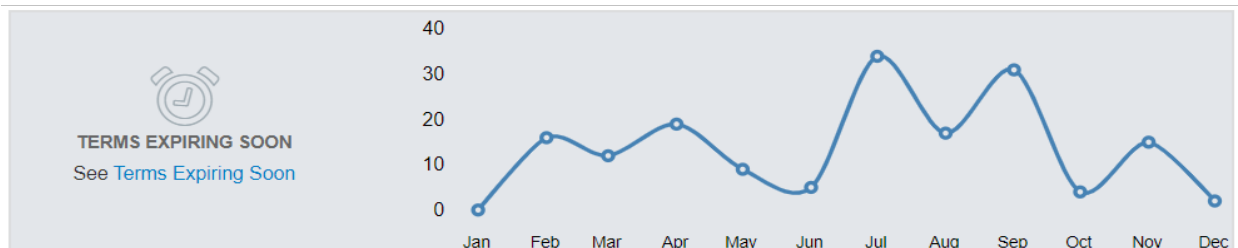
Graph 1

Presents information about board membership. There are currently 81 active board members, with complete information available for 27 boards and incomplete information for 54 boards. Among the 824 total board seats, 693 are occupied while 131 are unoccupied. Furthermore, there are 530 pending membership applications, with 156 recently submitted and 374 submitted more than six months ago.



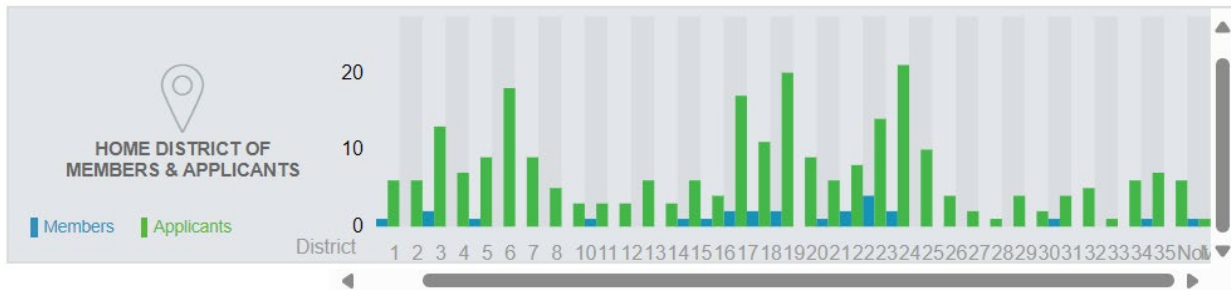
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in July and the lowest number in December.

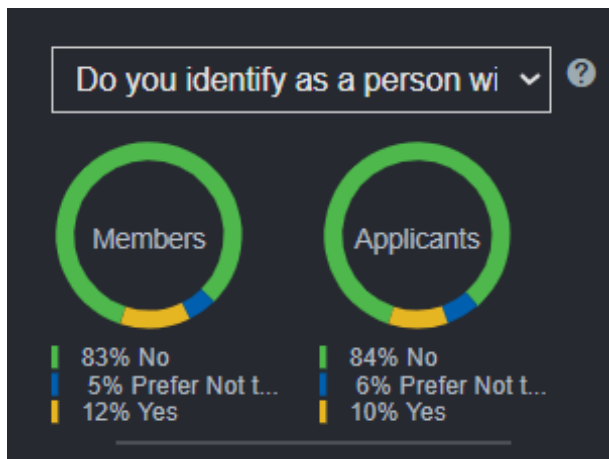


### Graph 3

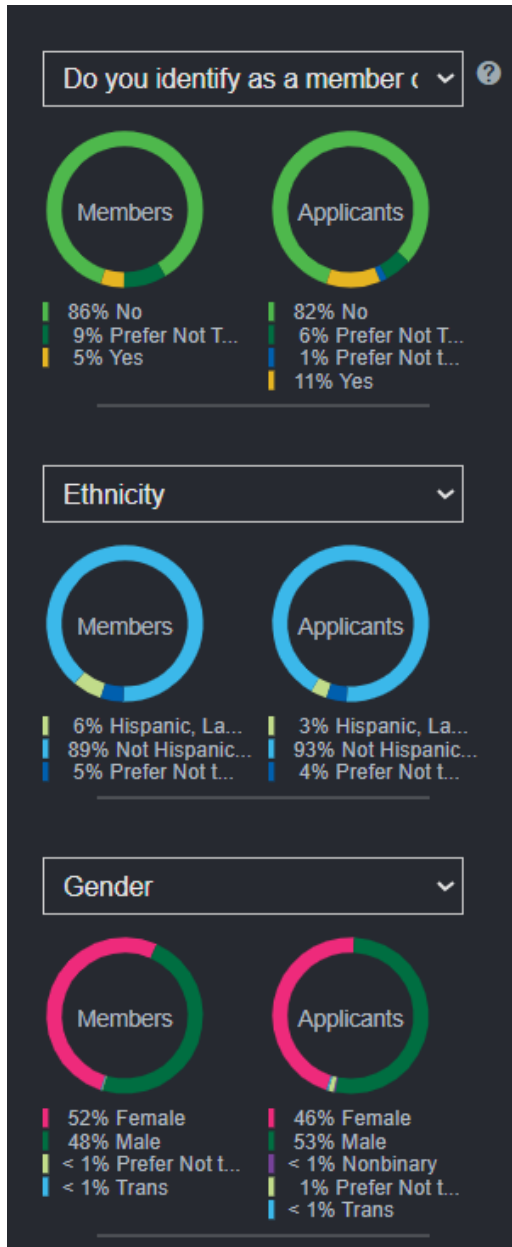


### Graph 4



Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 83% answered no, 5% prefer not to say, and 12% answered yes. For applicants 84% answered no, 6% prefer not to say, and 10% answered yes.

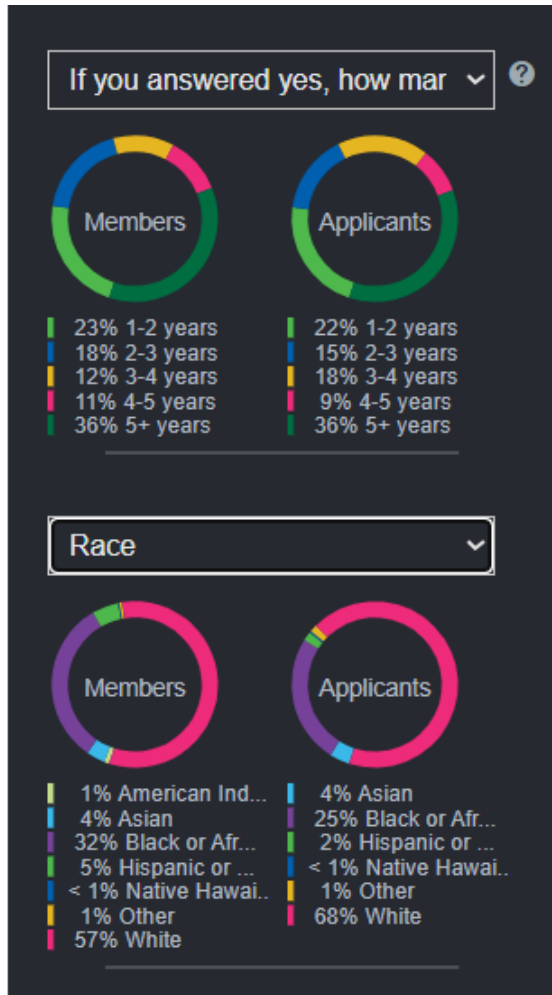


Presents data on LGBTQ+. For Members 86% do not wish to identify as LGBTQ+, 9% prefer not to say, and 5% openly identify as LGBTQ+. For Applicants 82% do not wish to identify as LGBTQ+, 7% prefer not to say, and 11% openly identify as LGBTQ+.

Data on Ethnicity show among members, 6% identify as Hispanic, Latino, or of Spanish origin, 89% do not identify as Hispanic, Latino, or of Spanish origin, and 5% prefer not to say. For applicants, 3% identify as Hispanic, Latino, or of Spanish origin, 93% do not identify as Hispanic, Latino, or of Spanish origin, and 4% prefer not to say, and

Data on Gender status show among members 52% identify as female and 48% identify as male, < 1% prefer not to say, and < 1% identify as Transgender. For applicants, 46% identify as female, 53% identify as male, < 1% identify as nonbinary, 1% prefer not to say, and < 1% identify as transgender.

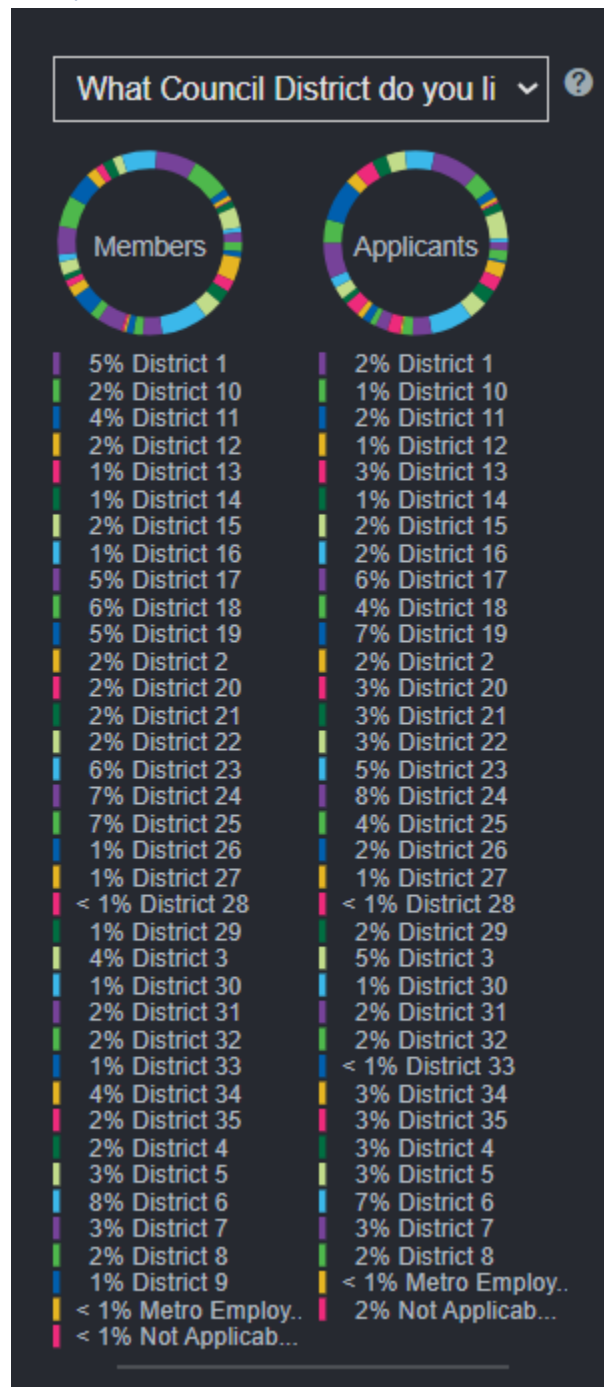

Presents data on years of service on the Metro Boards and Commission. For members 23% served 1-2 years, 18% 2-3 years, 12% 3-4 years, 11% 4-5 years, 36% 5+ years. For applicants 22% served 1-2 years, 15% 2-3 years, 18% 3-4 years, 9% 4-5 years, 36% 5+ years.

Presents data on Race Group. For members 1% American Indian, 4% Asian, 32% Black or African American, 5% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, 1% Other, 57% White. For applicants 4% Asian, 25% Black or African American, 2% Hispanic or Latino, <1% Native Hawaiian, 1% Other, 68% White.
