Graph 1

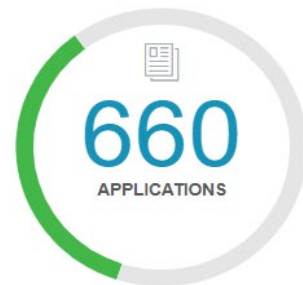
Presents information about board membership. There are currently 75 active board members, with complete information available for 26 boards and incomplete information for 49 boards. Among the 689 total board seats, 634 are occupied while 55 are unoccupied. Furthermore, there are 660 pending membership applications, with 230 recently submitted and 430 submitted more than six months ago.

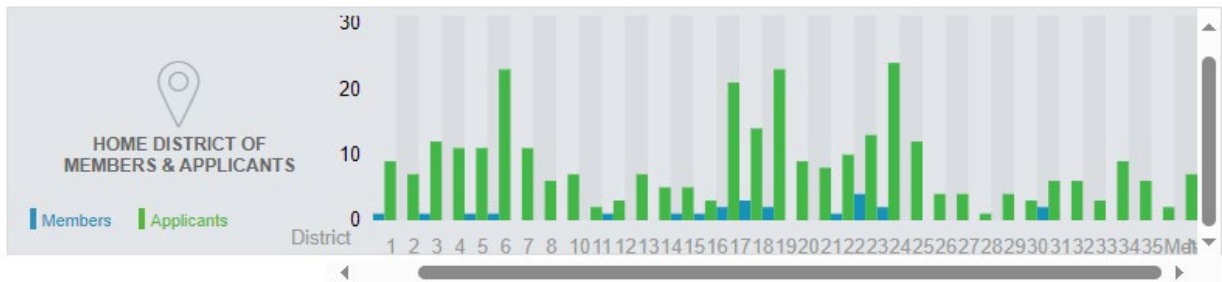
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in July and the lowest number in December.

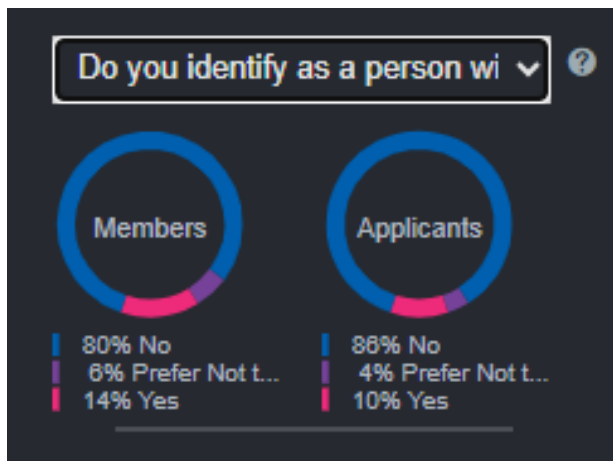

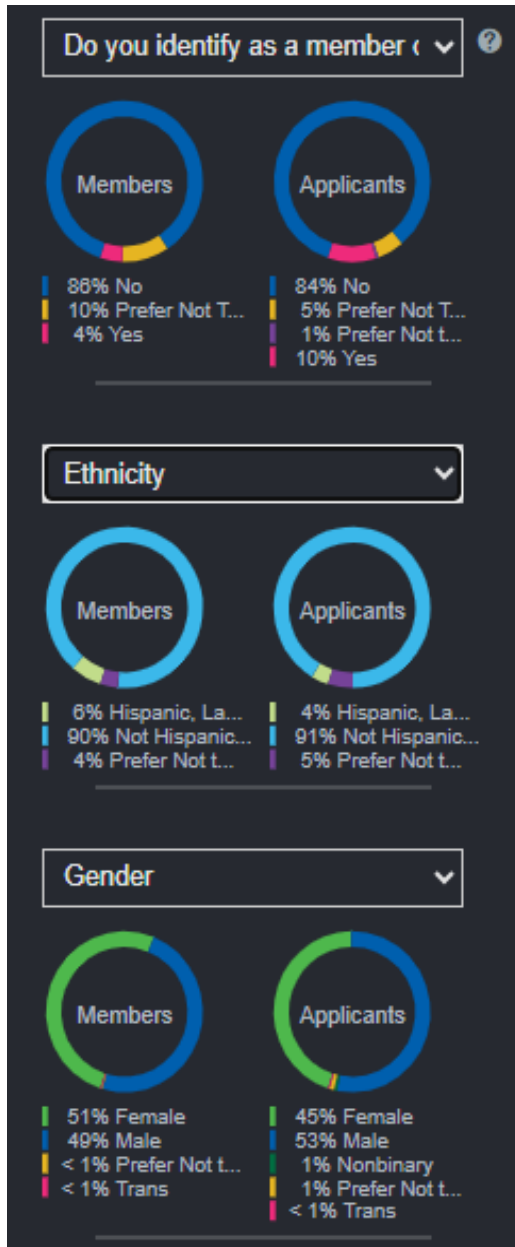

Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 80% answered no, 6% prefer not to say, and 14% answered yes. For applicants 88% answered no, 4% prefer not to say, and 10% answered yes.

Presents data on LGBTQ+. For Members 86% do not wish to identify as LGBTQ+, 10% prefer not to say, and 4% openly identify as LGBTQ+. For Applicants 84% do not wish to identify as LGBTQ+, 6% prefer not to say, and 10% openly identify as LGBTQ+.

Data on Ethnicity show among members, 6% identify as Hispanic, Latino, or of Spanish origin, 90% do not identify as Hispanic, Latino, or of Spanish origin, and 4% prefer not to say. For applicants, 4% identify as Hispanic, Latino, or of Spanish origin, 91% do not identify as Hispanic, Latino, or of Spanish origin, and 5% prefer not to say, and

Data on Gender status show among members 51% identify as female and 49% identify as male, < 1% prefer not to say, and < 1% identify as Transgender. For applicants, 45% identify as female, 53% identify as male, 1% identify as nonbinary, 1% prefer not to say, and < 1% identify as transgender.

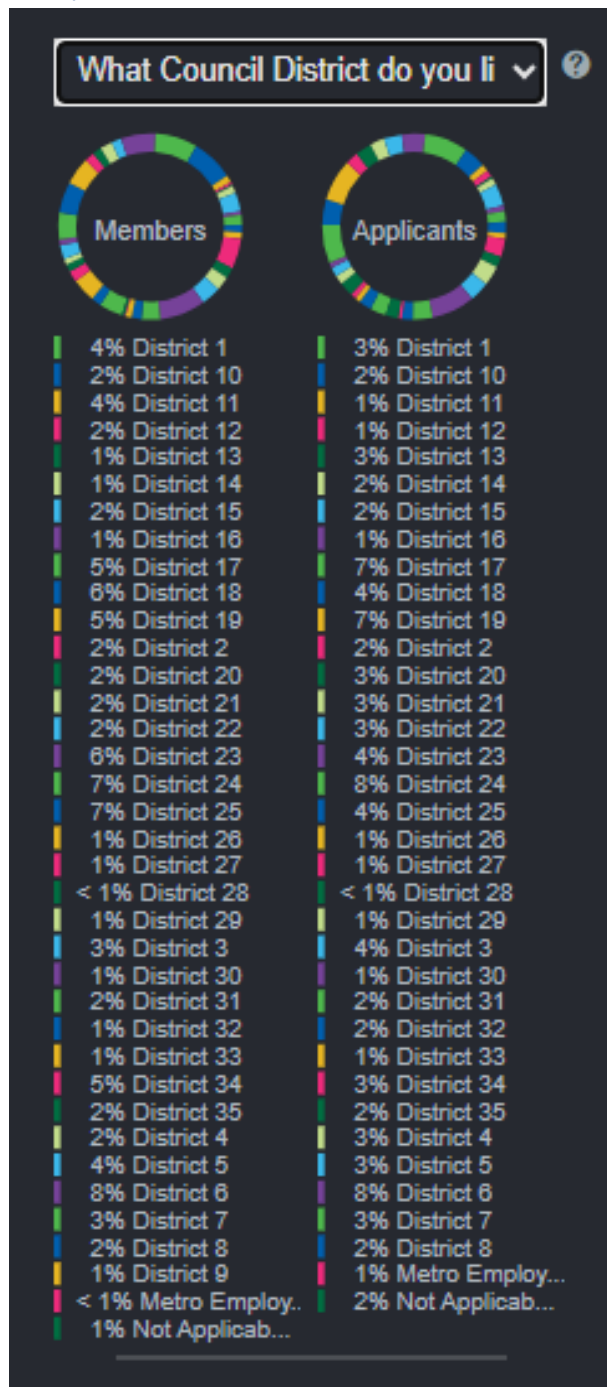

Presents data on years of service on the Metro Boards and Commission. For members 23% served 1-2 years, 18% 2-3 years, 10% 3-4 years, 12% 4-5 years, 37% 5+ years. For applicants 27% served 1-2 years, 6% 2-3 years, 20% 3-4 years, 8% 4-5 years, 39% 5+ years.

Presents data on Race Group. For members 1% American Indian, 4% Asian, 32% Black or African American, 5% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, 1% Other, 57% White. For applicants 4% Asian, 26% Black or African American, 2% Hispanic or Latino, <1% Native Hawaiian, 1% Other, 67% White.
