Graph 1

Presents information about board membership. There are currently 82 active board members, with complete information available for 28 boards and incomplete information for 54 boards. Among the 835 total board seats, 732 are occupied while 103 are unoccupied. Furthermore, there are 391 pending membership applications, with 229 recently submitted and 162 submitted more than six months ago.

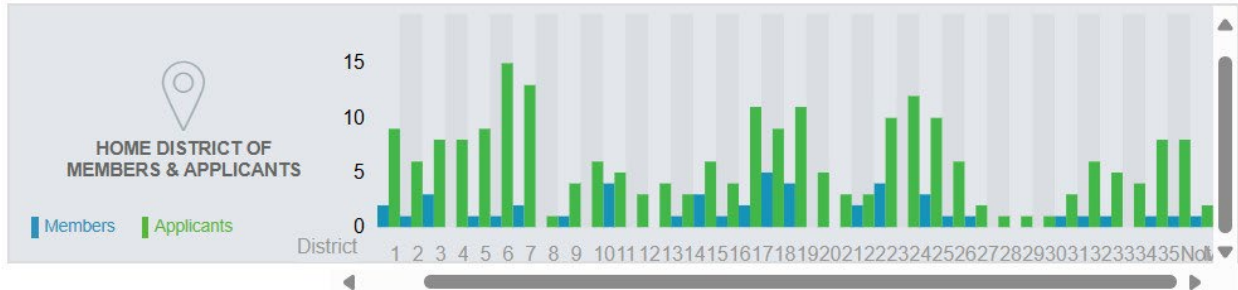
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in July and the lowest number in December.

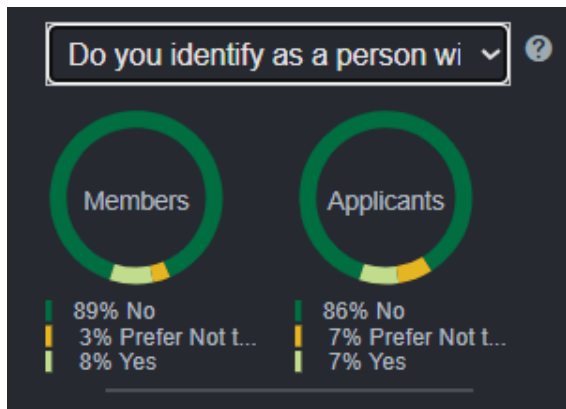

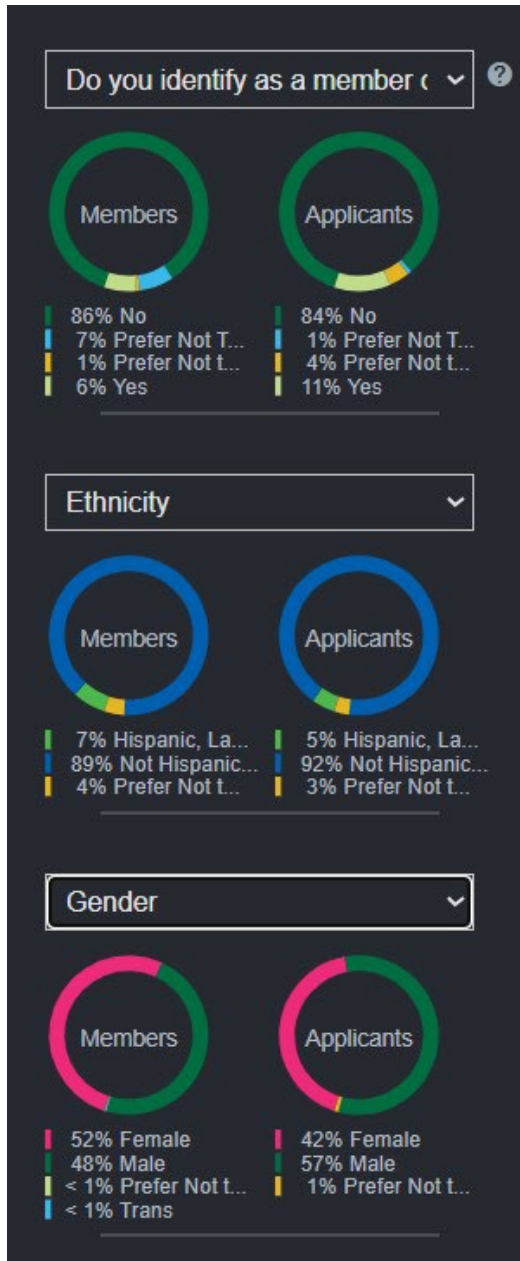

Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 89% answered no, 3% prefer not to say, and 8% answered yes. For applicants 86% answered no, 7% prefer not to say, and 7% answered yes.

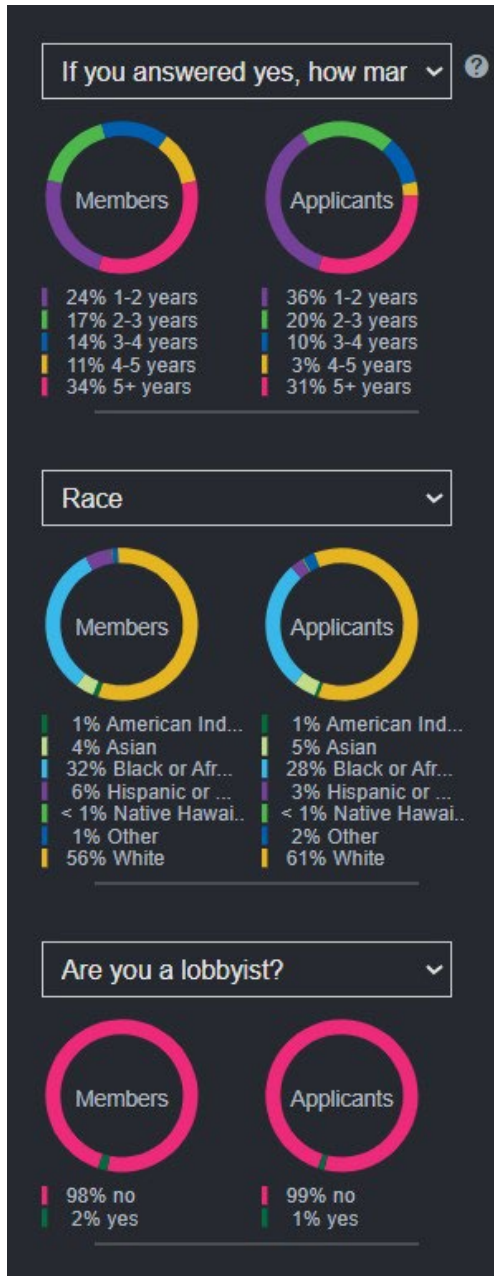


Presents data on LGBTQ+. For Members 86% do not wish to identify as LGBTQ+, 8% prefer not to say, and 6% openly identify as LGBTQ+. For Applicants 84% do not wish to identify as LGBTQ+, 5% prefer not to say, and 11% openly identify as LGBTQ+.

Data on Ethnicity show among members, 7% identify as Hispanic, Latino, or of Spanish origin, 89% do not identify as Hispanic, Latino, or of Spanish origin, and 4% prefer not to say. For applicants, 5% identify as Hispanic, Latino, or of Spanish origin, 92% do not identify as Hispanic, Latino, or of Spanish origin, and 3% prefer not to say.

Data on Gender status show among members 52% identify as female, 48% identify as male, < 1% prefer not to say, and < 1% identify as Transgender. For applicants, 42% identify as female, 57% identify as male and 1% Prefer Not to Say.

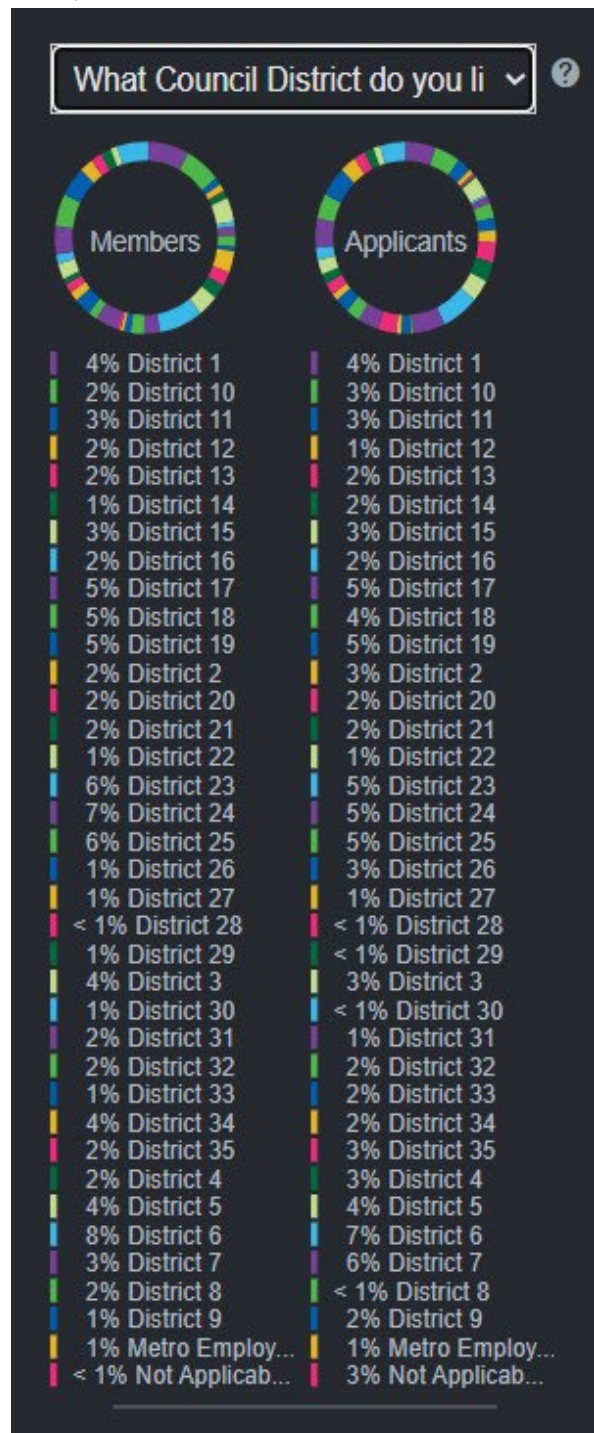


Presents data on years of service on the Metro Boards and Commission. For members 24% served 1-2 years, 17% 2-3 years, 14% 3-4 years, 11% 4-5 years, 34% 5+ years. For applicants 36% served 1-2 years, 20% 2-3 years, 10% 3-4 years, 3% 4-5 years, 31% 5+ years.

Presents data on Race Group. For members 1% American Indian, 4% Asian, 32% Black or African American, 6% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, 1% Other, 56% White. For applicants, 1% American Indian, 5% Asian, 28% Black or African American, 3% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, 2% Other, 61% White.

Provides information regarding individuals who are lobbyist. For members 98% answered no and 2% answered yes. For applicants 99% answered no and 1% answered yes.
