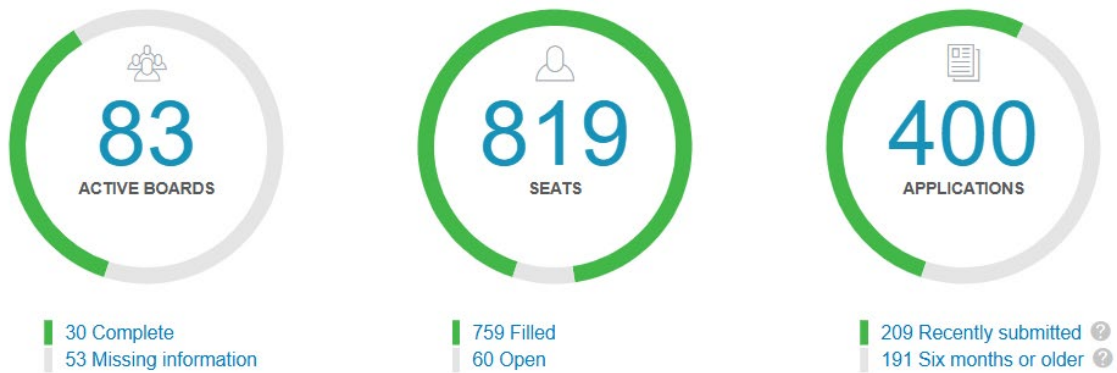


Boards and Commissions Graphs (ADA Compliant Script)

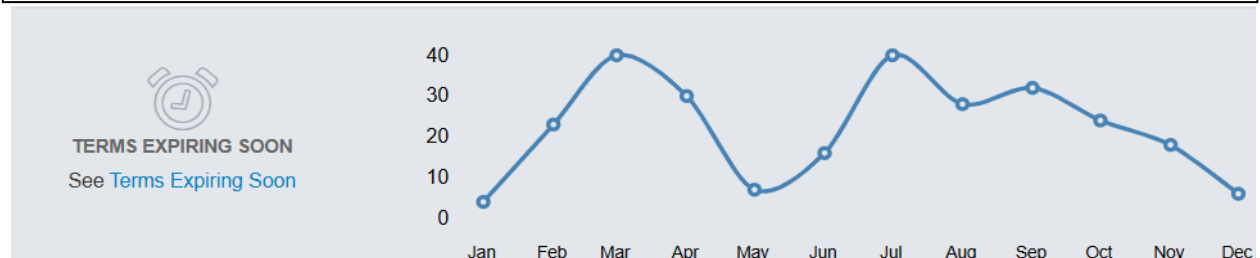
Graph 1

Presents information about board membership. There are currently 83 active board members, with complete information available for 30 boards and incomplete information for 53 boards. Among the 819 total board seats, 759 are occupied while 60 are unoccupied. Furthermore, there are 400 pending membership applications, with 209 recently submitted and 191 submitted more than six months ago.



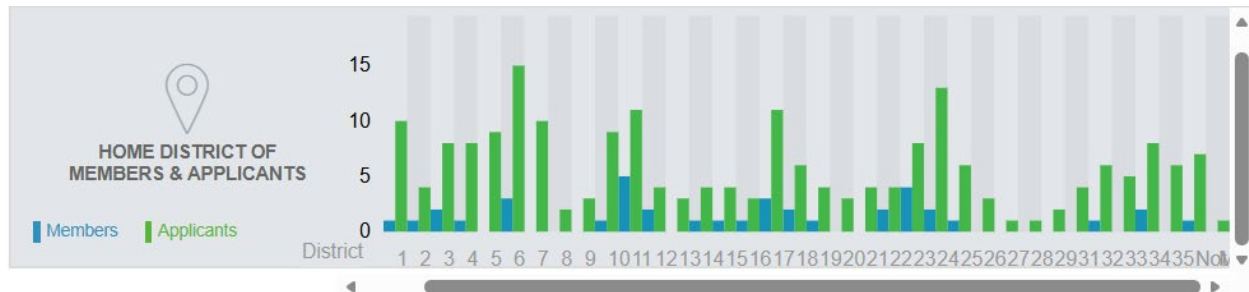
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in July and the lowest number in January.

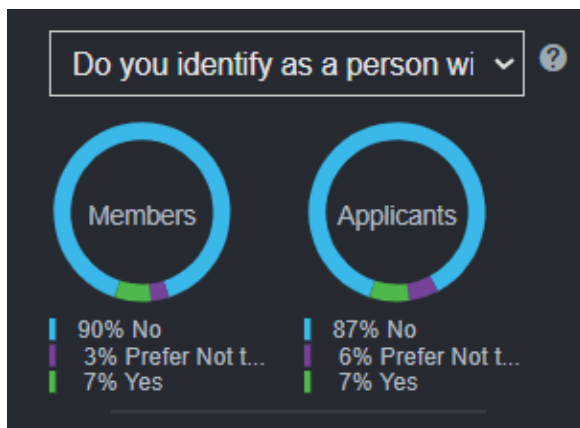

Illustrates the distribution of members and applicants across different districts, identified by their respective district numbers. However, it does not provide information regarding the number of applicants in each district. Please refer to Graph 7 for percentage value.

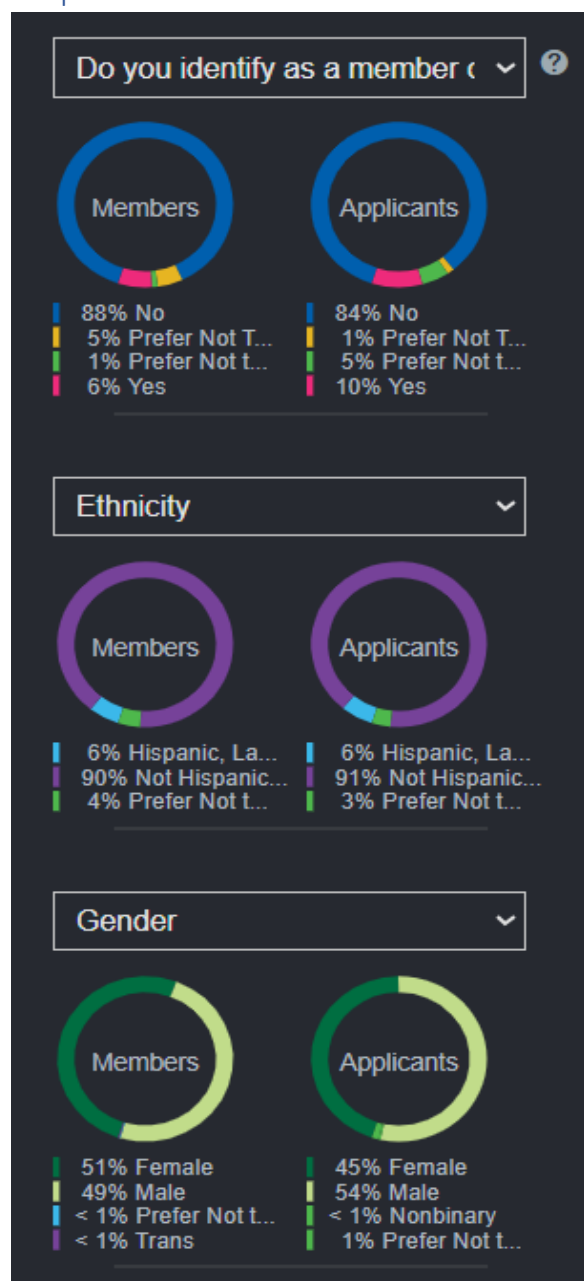

Provides information regarding individuals who are either members or applicants and self-identify as having a disability. For members 90% answered no, 3% prefer not to say, and 7% answered yes. For applicants 87% answered no, 6% prefer not to say, and 7% answered yes.

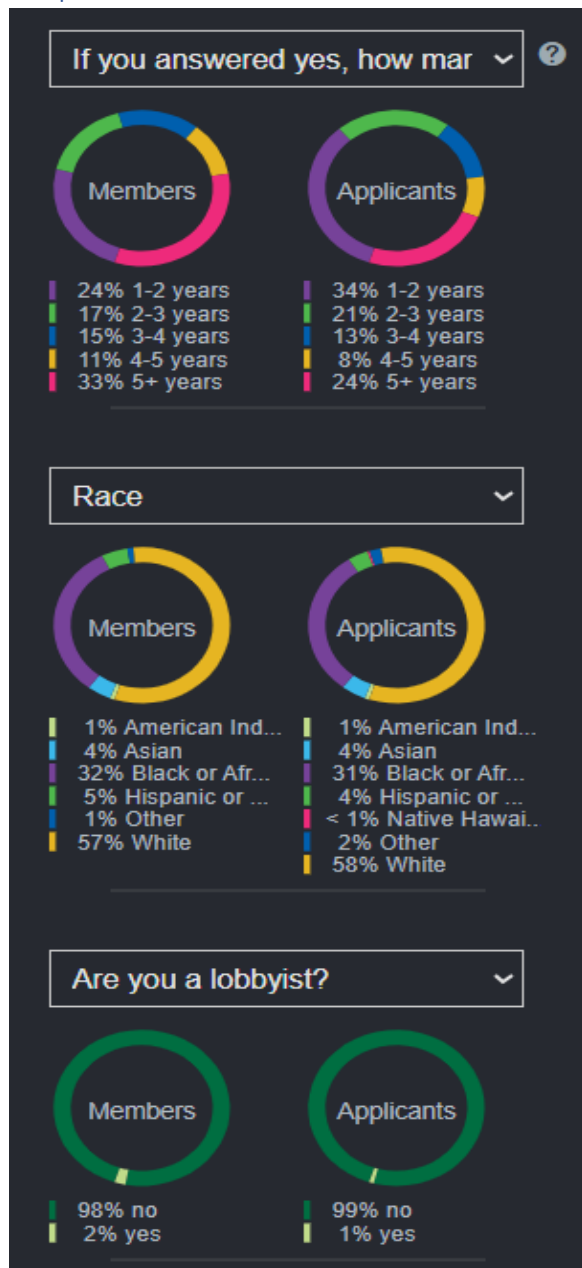


Presents data on LGBTQ+. For Members 88% do not wish to identify as LGBTQ+, 6% prefer not to say, and 6% openly identify as LGBTQ+. For Applicants 85% do not wish to identify as LGBTQ+, 6% prefer not to say, and 10% openly identify as LGBTQ+.

Data on Ethnicity show among members, 6% identify as Hispanic, Latino, or of Spanish origin, 90% do not identify as Hispanic, Latino, or of Spanish origin, and 4% prefer not to say. For applicants, 6% identify as Hispanic, Latino, or of Spanish origin, 91% do not identify as Hispanic, Latino, or of Spanish origin, and 3% prefer not to say.

Data on Gender status show among members 51% identify as female, 49% identify as male, < 1% prefer not to say, and < 1% identify as Transgender. For applicants, 45% identify as female, 54% identify as male, < 1% identify as Nonbinary, and 1% Prefer Not to Say.

Presents data on years of service on the Metro Boards and Commission. For members 24% served 1-2 years, 17% 2-3 years, 15% 3-4 years, 11% 4-5 years, 33% 5+ years. For applicants 34% served 1-2 years, 21% 2-3 years, 13% 3-4 years, 8% 4-5 years, 24% 5+ years.

Data on Race Group. For members 1% American Indian, 4% Asian, 32% Black or African American, 5% Hispanic or Latino, 1% Other, 57% White. For applicants, 1% American Indian, 4% Asian, 31% Black or African American, 4% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, 2% Other, 58% White.

Data that provides information regarding individuals who are lobbyist. For members 98% answered no and 2% answered yes. For applicants 99% answered no and 1% answered yes.

Illustrates the distribution of members and applicants across various districts of residence. Among members, 4% reside in District 1, 2% in District 10, 3% in District 11, 2% in District 12, 1% in District 13, 1% in District 14, 3% in District 15, 1% in District 16, 5% in District 17, 6% in District 18, 5% in District 19, 3% in District 2, 2% in District 20, 2% in District 21, 1% in District 22, 6% in District 23, 7% in District 24, 6% in District 25, 1% in District 26, 1% in District 27, less than 1% in District 28, 1% in District 29, 4% in District 3, 1% in District 30, 2% in District 31, 2% in District 32, 1% in District 33, 3% in District 34, 2% in District 35, 3% in District 4, 3% in District 5, 9% in District 6, 3% in District 7, 2% in District 8, 1% in District 9, 1% are Metro Employees, and less than 1% are Not Applicable.
